Dissertation: *Home Growing Teacher Quality: District Partnerships with Urban Teacher Residencies*. In response to high rates of new teacher turnover and the inequitable distribution of qualified teachers, Chicago and Boston central office leaders trained their own new teachers through partnerships with urban teacher residencies. Drawing upon urban regime analysis, this qualitative, two-site case study identified a typology of bridging strategies characterizing differing public-private partnerships. *Contractual bridging* and delegated *proxy control* of decision-making authority allowed one residency independence in the implementation of its alternative teacher preparation program and management of reconstituted district schools. *Collaborative bridging* and delegated *civic control* allowed another residency to nimbly respond to changing instructional needs of the district through formal and informal relationships. While both partnerships valued similar professional skills, they identified varying professional dispositions—character and activist—in their constructions of urban teacher quality. The thesis argued that the structure and funding arrangements of these district-residency partnerships allowed reformers to *tailor new teachers* and customize a workforce pipeline directed to difficult-to-staff classrooms.
