**AGREEMENT AND RELEASE FROM LIABILITY**

**This agreement is important. It includes terms and conditions and releases Ambassadors For Children from liability. It must be signed by all participants.**

“Ambassadors For Children” is defined to include its owners, agents, directors, officers, employees, representatives and affiliates, (collectively “AFC”). AFC does not own or operate any entity which is to or does provide goods or services for your trip including, for example, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of optional excursions, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, AFC is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party. Without limitation, AFC is not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to, acts of God, force majeure, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, overbooking or downgrading of accommodations, structural or other defective conditions in hotels or other lodging facilities, mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely, dangers associated with animals, marine life or vegetation or any sort, dangers incident to recreational activities such as scuba diving, snorkeling, swimming, kayaking, sailing, canoeing, rafting, hiking, bicycling, rock climbing, etc., sanitation problems, food poisoning, lack of, access to or quality of medical care, difficulty in evacuation in case of medical or other emergency, or for any other cause beyond the direct control of AFC. In addition, I release AFC from its own negligence and assume all risk thereof.

**ASSUMPTION OF RISK.** I am aware that travels such as that I am undertaking involves hazardous activities, some in remote areas of the world, with a risk of illness, injury or death which may be caused by forces of nature, the negligence of AFC, or other persons and companies known or unknown, or of willful or criminal conduct of third parties. I am also aware that medical services or facilities may not be readily available or accessible during some or all of the time during which I am participating on the trip. In order to partake of the enjoyment and excitement of this travel trip I am willing to accept the risks and uncertainty involved as being an integral part of my adventure. I hereby accept and assume full responsibility for any and all risks of illness, injury or death and of the negligence of AFC or of any third party.

**DELAYS & COST INCREASES.** The cost of delays is not included in any trip and if must be delayed due to bad weather, road conditions, transportation delays, government intervention, sickness or other contingency for which AFC or its agents cannot make provisions. Land costs and/or air faire are subject to increase without prior notice, even after you have signed up on the trip. We often publish our prices more than a year in advance. Between that time and the time of the trip's actual departure, we are occasionally faced with significant cost increases that we cannot absorb, i.e. international currency fluctuations or increases in the cost of services. We regret this situation, and we do everything we can to avoid raising prices, but sometimes it is unavoidable. We will do our best to limit such increases and will notify you as soon as we are able.

**AIRLINE CLAUSE.** The airlines are not to be held responsible for any act, omissions or event during the time passengers are not on board their planes or conveyance. The passage contract in use by the airlines concerned, when issued, shall constitute the sole contract between the airlines and such purchasers of these tours and/or passengers. Such conveyance, etc. is subject to the laws of the countries involved. Airlines used vary in degree of safety and risk. Many air carriers have an unknown safety and maintenance record. AFC is not liable for incidents involving airline safety, cancellations, service, risk, delays, etc. or incidents that result in injury or death as a result. Please read the conditions on the back of your airline tickets.

**MEDICAL & HEALTH.** It is vital that persons with medical problems make them known to us well before departure. The trip leader has the right to disqualify anyone at any time during the trip if he or she feels the trip member is physically or mentally incapable or if a trip member's continued participation will jeopardize the individual involved or the group. Refunds are not given under such circumstances. Hospital facilities for serious problems are often unavailable and evacuation can be prolonged, difficult and expensive. AFC assumes no liability regarding provisions of medical care.

**CANCELLED TRIPS.** AFC reserves the right to cancel any trip due to inadequate sign-up or other cause that makes the trip economically unfeasible for us to operate, but will inform you at least 45 days prior to departure. In such a case, a full refund of land costs is given, but AFC is not responsible for additional expenses incurred by members preparing the trip (i.e. non-refundable "Advance Purchase" air tickets, visa fees if applicable, clothing, equipment, and medical expenses).

**BAGGAGE.** AFC assumes no liability for loss or damage in transit and from an AFC trip or while on an AFC trip. We recommend purchasing the supplemental travel insurance package.
